# **DISTRICT MEETINGS TO BE HELD IN JANUARY**

Oconto Electric Co-op's service area is divided into seven geographic districts and each one is served by a director. Every three years, the term of the director from either two or three of the seven districts expires.

A district meeting is held primarily to nominate candidates to stand for election to fill the new term. OEC members interested in being elected to the board are nominated at their district meeting. At least one, but no more than two people, can be on the ballot to run for director from a district. If more than two people are nominated to run for director, an election will be held at the district meeting. The two people receiving the most votes will be placed on the ballot for the general election, which is held at the co-op's annual meeting on March 25. The 2017 district meetings will be held in Districts 4 and 6.

#### **District 6**


The incumbent director in District 6 is Dan Kanack. The meeting will be held Thursday, January 5, 2017, at Lena High School, 304 E Main Street in the Village of Lena. Registration begins at 6:30 p.m. and the meeting at 7 p.m. District 6 consists of the townships of Lena and South Brazeau in Oconto County and the township of Pound in Marinette County.

#### **District 4**

The incumbent director in District 4 is Doug Allen. The meeting will be held Thursday, January 19, 2017, at St. John's Lutheran Church, 1253 County Road J in Little Suamico. Registration begins at 6:30 p.m. and the meeting at 7 p.m. District 4 includes members in the township of Abrams, Chase, and Little Suamico Township that lies in T26N-R20E also in Oconto County.

In late December, all members in Districts 4 and 6 will receive an official notice of the meetings. All OEC members are welcome to attend a district meeting, but only the members from the specific district will be eligible to vote.

After the meeting a hot lunch will be served and door prizes awarded. And one lucky member at each district meeting will win \$100 cash prize!


