MEMBERS GATHER FOR OCONTO ELECTRIC COOPERATIVE'S 81ST ANNUAL MEETING

Sunshine and smiling faces greeted Oconto Electric Cooperative members at their 81st annual meeting on Saturday, March 24, in the Performing Arts Center at Oconto Falls High School.

The big news was a new wholesale power contract expected to yield hefty savings. After many years of purchasing wholesale power from Wisconsin Public Service Corp., Oconto Electric will be supplied by Minnesota Power beginning January 1, 2019, under a seven-year, fixed-rate contract.

Board Chairman David Hischke saluted the co-op's employees for working safely. "It's really exciting when I get to tell you that they ALL come home safely at the end of every day for 14 years straight! That's right, it has been 14 years since our last lost-time accident," said Hischke.

Thirteen \$2,500 scholarships were awarded to area high

school seniors. The amount, available through unclaimed capital credits, was increased from the previous \$1,000. In the meeting, Treasurer Dan Kanack reported the return of nearly \$774,000 in capital credits during 2017, for a total of \$15.7 million over the co-op's history.

The Community Change bill-rounding program provided 19 grants to support projects like warm quilts, literacy, and ensuring students have the tools they need to succeed, and also to families that were impacted by the loss of their homes to fires.

Re-election of two directors, the sole nominees at January district meetings, was approved by voice vote. Todd Duame and Vernon Gisenas will serve new three-year terms. Reorganization retained the lineup of board officers, keeping Hischke as chairman; Doug Allen, vice chairman; Duame, secretary; and Kanack, treasurer.



SURGE PROTECTION

Keeping your Electronics and Home Safe

The National Electrical Manufacturers Association estimates that **60-80%** of surges originate from **internal sources** (within a home or business). Keep your valuable electronics **safe** by protecting them from the surges that can **damage or destroy them**.

What is a power surge? A power surge is a sudden and unwanted **increase in voltage** that can damage, degrade or destroy electronic equipment. Surges can occur when large appliances, such as air conditioners, turn on and off. Surges can also originate from electric utilities or lightning.

LEVELS OF PROTECTION

Point-of-Use Surge Protection

Easy to use - just plug in.

Only protects electronics **plugged into the device**.

Must be **replaced** over time or after a major surge event.

SIFE Whole Home

Must be installed by a qualified electrician.

Provides protection for your entire electrical system at home including large appliances, outlets, and light switches.

Protects against **larger surges** and provides **longer lasting** surge protection than point-of-use devices.





No surge protection can handle a **direct lightning strike**. **Disconnect** sensitive electronics if you suspect a surge is coming.

Power strips and surge protectors are **not the same**. Not all power strips offer surge protection.

JAN STRANZ BIDS FAREWELL TO OEC AFTER NEARLY 26 YEARS OF SERVICE

Jan began her career at Oconto Electric Co-op in December of 1992 as the member services representative, focusing on electricity use and advising members of OEC programs.

Over the years she has worn many different hats at OEC, but one thing that never changed was working with the members. She has conducted home energy audits, managed appliance sales, worked with stray voltage efforts, helped relicense the hydro plant, planned the member appreciation picnic, managed the Community "Change" organization, and so much more.



The best part of her job was working with members and the co-op model. "Someone once told me to, keep your eye on the ball, and the ball is the member," she said.

Jan recalled that one of her favorite project-based accomplishments was working with others to relicense the Stiles hydroelectric plant, resulting in a new 30-year license. "There were no procedures to follow," she said. "I was learning on the fly. We had to figure it out and make sure it happened."

The most significant change Jan has seen in her career is the shift in technology. She said the level of support from the board of directors, management, and employees to continually evolve with technology has been great. It has allowed OEC to serve more members with fewer employees. The advancement to computers, internet, automated meters, and smartphones has allowed OEC to deliver the best services to members while maintaining a personal touch.

Jan is looking forward to her retirement and spending more time kayaking on the Oconto River. She plans to stay involved with local organizations and continue to serve on the HSHS St. Clare Memorial Hospital board and the Oconto Falls School board, and the Oconto County Economic Development Corporation board.

"We are very sad to lose someone with such a great amount of institutional knowledge. She has been here for 25 years, and knows a great deal of the history of this cooperative. I have never seen anyone that truly cares more about the work that she does at the co-op, and the members that she serves. She will surely be missed, but we are very happy for her and her husband, Al, and wish them many happy years of retirement," said OEC Chairman Dave Hischke.
