This event is a great opportunity to promote and support the industry, educate the public, and provide an experience for those who have never witnessed the daily operations of a farm. There is a very supportive group in Oconto County that puts on this breakfast.

Alsteen Farms, LLC is excited to showcase their farm for the 2021 Oconto County Breakfast on the Farm (originally scheduled for 2020 but postponed because of COVID-19). The farm last hosted Breakfast on the Farm in 2009.

The dairy was established in 1900 and then purchased in 1959 by Harvey and Marian Alsteen. They raised their three sons, Dave, Mike and Dan, on the farm. In 1993, Mike, his wife Pam, and their three children, Colby, Courtney and Carolyn, purchased the farm, which consisted of 85 cows and 400 acres.

The farm has continued to grow and adapt to new technology. The 85-stall stanchion barn was retrofitted into a double 10 parallel parlor in 1998 that is still used to milk 500 cows three times a day. Each milking takes around five hours. The farm also cares for an additional 500 non-milking cows. The Alsteens are very thankful for their nine full-time, three parttime, and seasonal employees who make it all possible.

The farm is currently in the process of expanding their current manure pit and constructing a new feed pad. The farm goes through 81,000 pounds of food per day (total mixed ration).

With cow comfort in mind, the free-stall barn has mattresses that are bedded with straw and sawdust and is equipped with sprinklers, fans, and cow brushes.

The Alsteens' acreage has increased to 1,800 acres of corn, soybeans, alfalfa, and wheat. The farm strives for sustainability to

ensure environmentally safe practices by utilizing technology such as variable rating seed, variable rate fertilizer and manure applications, planting cover crops, and integrating best management herbicide practices.

Bring your family and friends to walk around the farm and go in the barns to see the cows. What better

way to see where your food comes from.

The only big change you will see this year is that the eggs, pancakes, and sausage will be in pre-packed containers.

Machickanee Flowage Partial Drawdown

Q & A

Q: What is the purpose of the flowage partial drawdown?

A: The purpose of the planned drawdown is for management of aquatic invasive vegetation and sediment compaction. The goal is to reduce the presence of aquatic invasive plants within the impoundment and improve fish habitat by consolidating sediments.

Q: Who requested the partial drawdown?

A: The Machickanee Advancement Association (MAA) in collaboration with the Wisconsin Department of Natural Resources (WDNR) and Oconto Electric Cooperative (OEC).

Q: How did OEC get involved?

A: OEC is the license holder for the Stiles Project, and therefore is required to request permission for the partial drawdown from the Federal Energy Regulatory Commission (FERC).

Q: What is the anticipated start date of the partial drawdown?

A: The week of July 6, 2021, depending on weather conditions.

Q: What is the partial drawdown level?

A: The water level will be reduced by approximately five feet.

Q: How long will the partial drawdown take?

A: Lowering of the flowage water level is planned to occur over approximately 10 to 14 days at an average rate of 3 to 6 inches per day (depending on rainfall).

Q: How long will the partial drawdown last?

A: Once the maximum drawdown of five feet is reached, the water level will be maintained at this level for approximately 70 days.

Q: How long will it take to bring the water levels back up?

A: The flowage will be refilled over approximately 10 days to a level within the normal operational range.

Q: What will happen to stranded aquatic organisms?

A: Inspections of the dewatered areas will occur regularly to look for stranded aquatic organisms, including fish, mussels, tadpoles and more. The organisms will be relocated.

Q: Who will be looking for the stranded aquatic organisms?

A: The MAA will be providing volunteers that will be properly trained by qualified DNR personnel.

O: Will the boat lauches be accessible?

A: No they will not be accessible due to reduced water levels. Walk in access may be possible but not recommended due to increased safety risks.

Q: Will OEC be compensated for their loss generation?

A: Yes. Monies will be received from various grants that are available to compensate the loss of generation.
