Dan Kanack District 6


In District 4, incumbent Doug Allen and Jan Stranz were nominated to fill the director position. The final election by the membership will be at the annual meeting.

\*In accordance with the cooperatives bylaws, directors do not receive a salary for their services. Instead, each director receives a fixed fee compensation (per diem) of \$295 per full day and \$175 per half day for attendance at board meetings, training seminars, and while performing cooperative business. Directors are reimbursed actual out-of-pocket travel expenses when traveling for cooperative business purposes. (61200)

In accordance with our mortgage agreements with National Rural Utilities Cooperative Finance Corporation (NRUCFC), Rural Utilities Service (RUS) and CoBank, an independent audit is conducted of the cooperative's records each year. Our most recent audit was completed for the period ending December 31, 2022, by the auditing firm of Bauman Associates, Ltd., P.O. Box 1225, Eau Claire, WI 54702.

The audit included a complete examination of the past year's

operations and the income and expense entries to determine if they are made in accordance with generally accepted auditing and accounting standards. Other tests are made of accounting records and procedures as considered necessary by the auditors.

The auditing firm will present its report directly to the board of directors at a regularly scheduled board meeting. Copies of the completed audit are sent to NRUCFC, RUS, and CoBank and are available for review at the office of the cooperative.





### Oconto Electric Cooperative's 85th Annual Meeting Highlights

Oconto Falls, Wisc. — After another long year of the COVID pandemic, Oconto Electric Cooperative was finally able to once again conduct their 85th annual meeting in-person, in the Oconto Fall Performing Arts Center on April 9, 2022.

Chairman Duame determined a quorum of 154 voting members in attendance and called the meeting to order.

Pastor Bill Tisch of Our Saviors Christian Church in Pulaski, WI provided the invocation.

Chairman Duame presided over the meeting and called for the Pledge of Allegiance.

Introductions of the board of directors and guests in attendance were recognized. Chairman Duame called for a moment of silence in memory of Director Vernon Gisenas who passed away on June 25, 2021. Director Dennis Langenberg was introduced and appointed by the board of directors to complete the remaining term of Director Gisenas representing members of District 1.

Cooperative Attorney Howard Eslien will conduct the meeting following Roberts Rules of Order. All member questions will be limited to three (3) minutes.

Secretary Dan Kanack was called upon to provide the reading of the official meeting notice of the 85th annual meeting and proof of mailing, which was a postcard sent via mail on March 21, 2022, and by email for those on paperless notifications to each member of the cooperative.

A Motion was made and seconded to waive the reading of the 2021 84th OEC annual meeting minutes and accept as published. *Motion Carried*.

Treasurer Tony Wagner was called upon to provide the 2021 Financial Report, reporting the cooperative was found to be in good financial standing. It was noted that the 2021 Cooperative's Audit report was published in the March issue of the WEC News magazine, and could also be found on OEC's website at: www.ocontoelectric.com.

Cooperative Attorney Howard Eslien called for a motion to approve and ratify the reports and actions taken by the officers and directors for 2021. A Motion was made and seconded to approve as presented. *Motion Carried*.

Attorney Eslien continued with a call from the membership for a unanimous voice-vote for Incumbent Director(s), David Hischke – District 2, Tony Wagner – District 3, and Ronnie Kruse – District 5, to serve another three (3) year term. All three directors were solely nominated at their district meetings held in January 2022. A unanimous voice-vote was cast and accepted.

Chairman Duame called upon Community Change board

member Jan Stranz to provide its annual report.

A moment of silence was observed for all veterans who served, past and present, in keeping our freedom and country safe.

Chairman Duame and CEO Byron Nolde provided their annual reports, with the chairman sharing a trip down memory lane depicting how automation has changed many of the cooperative procedures over the years. Chairman Duame informed members and congratulated Nolde on receiving the prestigious Ally of Cooperative Electrification (ACE) Award. The honorees of this Wisconsin Electric Cooperative Association award are those who have truly made outstanding contributions to the rural electrification in Wisconsin. Congratulations to CEO Nolde. Additional report updates included the following cooperative topics: the Machickanee flowage drawdown, major storms, ROPE (Restoration of Power in an Emergency), RUS (Rural Utilities Service), COVID 19, future industry challenges of electric cars and battery storage, employee charities, and generator safety hook-up.

CEO Nolde concluded his report with a special presentation in acknowledging the recent retirement announcement of longtime employee Kent Lyng, engineer. Kent has served the cooperative and membership with 33 years of dedicated service. A slideshow was viewed depicting some of Kent's many contributions and accomplishments throughout his career at OEC. A member's letter was also read thanking Kent for his dedication to the cooperative in helping its members with heating and/or water heater problems, even if the member's problem occurred on Christmas Eve. On behalf of the board of directors and cooperative, Kent received a standing ovation and was wished the very best in his well-deserved upcoming retirement.

Chairman Duame asked if there was any old or new business to be discussed. Hearing no other business, the chairman recognized the 2022 OEC Scholarship recipients in attendance.

This concluded the business portion of the meeting. A motion was made and seconded to adjourn. *Motion Carried*.

Before members dispersed the annual membership drawing of \$1,000 dollars was conducted. (All co-op member names are entered in the drawing – member must be present to win). Members Brett and Debra Zahn of Gillett were drawn, but they were not in attendance. The second drawing was the \$100 cash members in attendance drawing. Member James Swiecichowski was the winner of the \$100 cash. The meeting concluded with the final drawing of gifts donated by vendors. Chairman Duame extended a final thank you to all for attending the meeting.
